Attorney Andreoni told the council that the figures represent Joel Hopkins' recommendations based on feedback from Commissioner Rivara and the rest of the council. A MOTION WAS MADE BY RIVARA, SECONDED BY CAREY, to accept Ordinance No. 956-071717, Prevailing Wage. AYES: CAREY, PORTER, RIVARA, FINLEY. MOTION CARRIED.

A MOTION WAS MADE BY PORTER, SECONDED BY RIVARA to accept and place on file Building Inspector Brian Spelich's 2017 2<sup>nd</sup> Quarter Report, which showed permits issued for \$557,190.00 in new construction and renovations. AYES: CAREY, PORTER, RIVARA, FINLEY. MOTION CARRIED.

A MOTION WAS MADE BY CAREY, SECONDED BY RIVARA to seek bids for a bucket truck for the Electric Department. Carey told the council that the department "was in dire need" of a new truck, noting "numerous issues" with the 19-year-old truck. AYES: CAREY, PORTER, RIVARA, FINLEY. MOTION CARRIED.

A MOTION WAS MADE BY RIVARA, SECONDED BY CAREY to accept Motor Fuel Tax Resolution No. R1-071717, which allocates up to \$3,000 more for the summer street program. AYES: CAREY, PORTER, RIVARA, FINLEY. MOTION CARRIED.

A MOTION WAS MADE BY PORTER, SECONDED BY CAREY to place on file Ordinance No. 957-080717, Memorandum of Agreement with the Fraternal Order of Police. Commissioner Porter apologized to the council for not getting the memorandum to them sooner. He explained that the memo clarifies language addressing health insurance premiums and the salary schedule. AYES: CAREY, PORTER, RIVARA, FINLEY. MOTION CARRIED.

The Mayor asked for comments from the public. There were none.

Commissioner & Mayor reports:

Commissioner Rivara reiterated his concerns about first responder safety and said he was working with IMEA trainer Ron Cook to do two safety sessions for \$500 per session, mileage and a per diem. Rivara said he felt so strongly about the need that he would pick up the cost of one session. He then asked about the Dickinson House roof leak. Mayor Finley told him that he was still waiting to hear back from the Foundation.

Commissioner Carey told the council that there were "a lot of branches out there" because of recent storms and that his department would be picking up branches in the next 10 days or so. Carey said that this would be the last pick up until Fall.

Commissioner Porter told the council that the 1995 ambulance would need to be replaced "real soon."

Mayor Finley reminded residents about the baseball tournament and thanked the many volunteers for their efforts during Summer Fun Fest.

A MOTION WAS MADE BY PORTER, SECONDED BY CAREY at 7:15 p.m. to enter into executive session to discuss "collective negotiation matters between the public body and its employees or their representatives, or deliberations concerning salary schedules for one or more classes of employees." and "pending and potential litigation."
