ORDINANCE NO. 1108-040620

AN ORDINANCE VACATING A UTILITY EASEMENT IN
THE CITY OF OGLESBY, LASALLE, COUNTY, ILLINOIS

WHEREAS, the City of Oglesby has a utility easement through a portion of Lot 6, 7 and 8 in Assessor's Block 16 and in a part of Lot 11 in Bent's Point Lookout Park Subdivision located within the City of Oglesby, in the County of LaSalle, said utility easement being more fully described in the attached Plat of Survey marked as Exhibit A and incorporated by reference as if set out in full herein; and

WHEREAS, the corporate authorities of the City of Oglesby have determined that the utility easement is of no benefit to the City of Oglesby and that the utility easement will not be needed by the City of Oglesby for future development; and

WHEREAS, the owners of the real estate where the easement is located, Edward Dombrowski and Lynne Dombrowski, have asked that the City of Oglesby vacate the easement described in Exhibit A; and

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the best interest of the residents of the City of Oglesby to grant Mr. and Mrs. Dombrowski's easement vacation request.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby vacates the utility easement running through the following described private property located in the City of Oglesby, LaSalle County, Illinois as follows:

The East 50 feet of Lots 6,7, and 8 in Block 16 in Assessor's Plat of a portion of Section 25, Township 33 North, Range 1 East of the Third Principal Meridian, situated in the City of Oglesby, LaSalle County, Illinois; and the Westerly 20 feet of Lot 11 in Bent's Point Lookout Park Subdivision, situated in the City of Oglesby, LaSalle County, Illinois.

3. The City Clerk of the City of Oglesby is hereby authorized to provide a certified copy of this ordinance to Edward Dombrowski and Lynne Dombrowski for recording in the LaSalle County Recorder of Deeds office.

4. This ordinance shall remain in full force and effect after its approval, passage, and publication in pamphlet form as provided by law.
