ORDINANCE NO. 1124-090820

AN ORDINANCE AMENDING ORDINANCE NO. 1024-061818 ENTITLED AN ORDINANCE ESTABLISHING WAGES FOR OGLESBY AMBULANCE SERVICE EMPLOYEES

WHEREAS, the Oglesby City Council adopted Ordinance No. 1024-061818 entitled An Ordinance Establishing Wages for Oglesby Ambulance Service Employees; and

WHEREAS, one of the provisions of Ordinance No. 1024-061818 limited the number of employees who could work for the Oglesby Ambulance Service for more that one thousand (1,000) hours in a calendar year; and

WHEREAS, the corporate authorities of the City of Oglesby have determined that appropriate operation of the ambulance service requires the Oglesby Ambulance Service to be allowed to hire a total of three (3) Oglesby Ambulance Service employees who would be authorized to work more than one thousand (1,000) hours per year; and

Section 11-5-7 of the Illinois Municipal Code (65 ILCS 5/11-5-7) authorizes municipalities to operate an ambulance service and to employ individuals to work for the municipality in said service; and

WHEREAS, the corporate authorities of the City of Oglesby deem it to be in the public interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this ordinance establishing wages for Oglesby ambulance service employees.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are restated and reincorporated by reference as if set out in full herein.

2. Paragraph number eight (8) of Ordinance No. 1024-061818 shall be amended to read as follows:

Two (2) EMT paramedic employees, Ronald Popurella and Dean Harper, shall remain part time employees, but will be allowed to work up to one thousand eight hundred (1,800) hours in a calendar year and, if they work in excess of one thousand (1,000) hours, will be eligible for IMRF benefits but shall remain part time employees and not be eligible for any other benefits other than IMRF. One (1) additional ambulance service employee, whether EMT paramedic employee, EMT "I" employee or EMT(B) employee shall remain a part time employee, but will be allowed to work up to one

thousand (1,800) hours in a calendar year and, if they work in excess of one thousand (1,000) hours, will be eligible for IMRF benefits, but shall remain a part time employee and not be eligible for any other benefits other than IMRF. It shall be up to the discretion of the ambulance service director, after receiving approval from the Commissioner of Public Health and Safety, to select the one (1) additional employee who will be allowed to work in excess of one thousand (1,000) hours, but less than one thousand eight hundred (1,800) hours in a calendar year for the Oglesby Ambulance Service.

All other Oglesby Ambulance Service employees shall be part time employees and shall not work more than nine hundred ninety-five (995) hours in a calendar year. The wages provided herein for the part time members of the Oglesby Ambulance Service, including Ron Popurella, Dean Harper and one (1) additional employee selected by the director to work in excess of one thousand (1,000) hours in a calendar year, do not include any other employment benefits provided to full time employees of the City of Oglesby such as health insurance, longevity pay (except as provided for in this ordinance), vacation days, sick days, holidays, leave of absence benefits, clothing allowances and retirement benefits.

3. All of the remaining provisions of Ordinance No. 1024-061818 not otherwise amended by

this ordinance shall remain in full force and effect.

4. This ordinance shall remain in full force and effect after its passage, approval and

publication in pamphlet form as provided by law.
