**AN ORDINANCE PROVIDING FOR ADDITIONAL
COMPENSATION FOR OGLESBY EMPLOYEES ASSUMING
THE ROLE OF EVENT PLANNERS**

WHEREAS, the City of Oglesby has contacted certain City employees and asked these employees to take on additional duties as event planners for the City; and

WHEREAS, the employees who have agreed to assist the City of Oglesby as such event planners are: AMY EITUTIS, JOHN ROSE and ERIN QUICK; and

WHEREAS, these City of Oglesby employees will take on additional duties as event planners which duties will be above and beyond and in addition to their regularly assigned work for the City of Oglesby; and

WHEREAS, the corporate authorities of the City of Oglesby have agreed to provide an additional bonus to these employees for their additional work as event planners for the City of Oglesby, the work of these employees as event planners for the City of Oglesby shall be subject to the direction and control of Mayor Rivara and Commissioner Argubright, and in addition to assuming the additional work as event planners for the City of Oglesby, AMY EITUTIS, JOHN ROSE, and ERIN QUICK agree to assume all responsibility for municipal events approved by the corporate authorities of the City of Oglesby, such as Oglesby Fun Fest and other annual promotional events sponsored by the City of Oglesby; and

WHEREAS, the corporate authorities of the City of Oglesby have decided that the City of Oglesby will award AMY EITUTIS, JOHN ROSE and ERIN QUICK

each a one-time bonus in the amount of Two Thousand and no/ 100 Dollars (\$2,000.00) on July 1, 2021, to compensate them for the additional work they have agreed to perform as event planners for the City of Oglesby; and

WHEREAS, Section 10-4-1 of the Illinois Municipal Code (65 ILCS 5/10-4-1) provides the City of Oglesby with broad authority to provide by ordinance with regard to all municipal officers and employees of the City, and, by implication, authorizes the payment of the bonuses set forth in this Ordinance to the employees named herein.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Commissioners of the City of Oglesby, LaSalle Count, Illinois as follows:

1. The recitals contained in the preamble to this Ordinance are restated as if set out in full herein.

2. The City of Oglesby does hereby authorize and grant bonus payments of Two Thousand and no/100 Dollars (\$2,000.00) each to AMY EITUTIS, JOHN ROSE, and ERIN QUICK to compensate these employees for the additional duties which they have agreed to assume and perform as event planners for the City of Oglesby. Said Two Thousand and no/100 Dollars (\$2,000.00) bonus payments shall be paid to said employees on or about July 1, 2021, and on the 1st day of July of each successive year that said employees agree to perform said extra work as event planners for the City of Oglesby, unless changed by subsequent Ordinance.

3. This Ordinance shall be in full force and affect after its passage, approval, and publication in pamphlet form as provided by law.

4. The City Clerk is hereby instructed to publish this Ordinance in pamphlet form as

required by law.
