**AN ORDINANCE AMENDING CERTAIN PARAGRAPHS
OF SECTIONS 10.24.050 AND 10.27.075 OF THE MUNICIPAL CODE
OF THE CITY OF OGLESBY RELATING TO NO PARKING ZONES
ON CERTAIN CITY STREETS**

WHEREAS, residents of the City of Oglesby have voiced complaints about the enforcement of certain existing no parking zones on certain city streets in the City of Oglesby, LaSalle County, Illinois; and

WHEREAS, an there has been an in-depth consideration and discussion of existing no parking zones on certain city streets in the City of Oglesby, LaSalle County, Illinois; and

WHEREAS, said existing no parking zones are codified in Sections 10.24.050 and 10.24.075 of the Municipal Code of the City of Oglesby, LaSalle County, Illinois; and

WHEREAS, the corporate authorities of the City of Oglesby deem it to me in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to amend certain paragraphs of Sections 10.24.050 and 10.27.075 of the Municipal Code of the City of Oglesby as set forth herein so as to adjust said no parking zones,

NOW THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Oglesby, LaSalle County, Illinois:

SECTION 1: That paragraphs "5.", "13." and "15." of Section 10.24.050 of the Municipal Code of the City of Oglesby are hereby deleted in their entirety and the following new paragraph "5." is hereby substituted in place of the previous paragraph "5." in said Section 10.24.050:

5. There shall be no parking permitted along the East side of

Jones Avenue from Mormon Street to Crockett Street.

No replacement paragraphs shall be substituted for the paragraphs "13." and "15." in said Section 10.24.050 which are herein deleted and said paragraphs are hereby reserved for possible future use.

SECTION 2: That paragraphs "D.", "E.", "F.", "J.", "L.", "M.", and "N." of Section 10.24.075 of the Municipal Code of the City of Oglesby are hereby deleted in their entirety and the following new paragraphs "D.", "E.", "F.", "L.", "M." and "N." are hereby substituted in place of said previous paragraphs "D.", "E.", "F.", "L.", "M.", and "N." in said Section 10.24.075:

D. There shall be no parking permitted along the South side of Florence Street from Columbia Avenue to Woodland Avenue.

E. There shall be no parking permitted along the West side of School Street from First Street to Walnut Street.

F. There shall be no parking permitted along the North side of Morris Street from Swift Avenue to Wyatt Avenue.

L. There shall be no parking permitted along the North side of Prospect Street.

M. There shall be no parking permitted along the North side of Jordan Street from the intersection of Jordan Street and Woodland Avenue to the intersection of Jordan Street and Columbia Avenue.

N. There shall be no parking permitted along the both sides of Pool Drive from Trexler Avenue to Lehigh Avenue, on the East side of Lehigh Avenue from Pool Drive to Walnut Street and on the East side of Trexler Avenue from Walnut Street to Pool Drive.

No replacement paragraph shall be substituted for the paragraph "J." in said Section 10.24.075 which is herein deleted and said paragraph is hereby reserved for possible future use.

SECTION 3: That if any section, subdivision, or sentence of this Ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portion of this Ordinance.

SECTION 4: That this Ordinance shall be in full force and effect after its passage, approval, and publication, as provided by law.
