**AN ORDINANCE GRANTING A REQUEST FOR VARIANCES
FILED BY AMEREN ILLINOIS COMPANY SO AS TO ALLOW FOR

WHEREAS, the City of Oglesby received a request for variances from **AMEREN ILLINOIS COMPANY, d/b/a AMEREN ILLINOIS**, for property located at 443 S. Columbia Avenue in the City of Oglesby, County of LaSalle and State of Illinois; and

WHEREAS, the Oglesby City Council referred this matter to the Oglesby Zoning Board of Appeals; and

WHEREAS, the Oglesby Zoning Board of Appeals conducted a public hearing on April 29, 2021, after due notice as provided in the Illinois Municipal Code and the Land Development Code of Oglesby, Illinois; and

WHEREAS, at the conclusion of said hearing the Oglesby Zoning Board of Appeals recommended to the Oglesby City Council that Ameren Illinois' variance requests be granted, allowing for the erection of an eight-foot (8') front yard fence with barbed wire (7' fence plus 1' barbed wire) and allowing for forty-six percent (46%) of its land to be utilized for a sub-station and

WHEREAS, at its regularly scheduled meeting on May 3, 2021, the City Council of the City of Oglesby, LaSalle County, Illinois, approved the variance requests, allowing for the erection of an eight-foot (8') front yard fence with barbed wire (7' fence plus 1' barbed wire) and allowing for forty-six percent (46%) of its land to be utilized for a sub-station; and

WHEREAS, Section 11-13-5 of the Illinois Municipal Code (65 ILCS 5/11-13-5) authorizes municipalities to grant variances from the strict application of municipal zoning ordinances; and

WHEREAS, the Oglesby City Council deems it to be in the best interest of the public health, safety and welfare of the residents of the City of Oglesby to adopt this Ordinance to formalize the grant of variance requests recommended by the Oglesby Zoning Board of Appeals and previously approved by the Oglesby City Council on May 3, 2021,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. There are hereby granted variances allowing for the erection of an eight-foot (8') front yard fence with barbed wire (7' fence plus 1' barbed wire) and allowing for forty-six percent (46%) of its land to be utilized for a sub-station, for the property located at 443 S. Columbia Avenue, in the City of Oglesby, LaSalle County, Illinois, which property is legally described as follows.

The South one-half (S1/2) of the East one-half (E1/2) of the Northeast Quarter (NE1/4) of Section Thirty-five (35), Township Thirty-three (33) North, Range one (1) East of the Third Principal Meridian, situated in the County of LaSalle in the State of Illinois.

P.I.N. Numbers: 18-35-252-000, 18-35-253-000 and the South 95' of 18-35-250-000.

3. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
