ORDINANCE NO. 1076-081919

AN ORDINANCE APPOINTING AMY L. EITUTIS CITY CLERK
FOR THE CITY OF OGLESBY AND ESTABLISHING THE SALARY
AND BENEFITS TO BE PAID TO THE OGLESBY CITY CLERK

WHEREAS, the City of Oglesby desires to establish the wage and benefits to be provided to the Oglesby City Clerk; and

WHEREAS, the position of City Clerk in the City of Oglesby is an appointed position; and

WHEREAS, Section 4-6-2 of the Illinois Municipal Code (65 ILCS 5/4-6-2) authorizes the City of Oglesby to set compensation for all officers and employees of the City of Oglesby; and

WHEREAS, Section 4-5-4 of the Illinois Municipal Code (65 ILCS 5/4-5-4) provides for the appointment of the City Clerk in city's under a commission form of government; and

WHEREAS, the Mayor and City Council of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to adopt an ordinance setting the salary and benefits to be paid to the Oglesby City Clerk.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are restated and incorporated by reference as if set out in full herein.

2. The City of Oglesby hereby appoints Amy L. Eitutis as City Clerk of the City of Oglesby retroactive to July 1, 2019. Amy L. Eitutis' term as City Clerk for the City of Oglesby shall expire on April 30, 2023, unless she is reappointed by the Mayor and City Council of the City of Oglesby to continue in the position of City Clerk after the April 2023 municipal elections.

3. For the period from July 1, 2019 through April 30, 2020, the City Clerk of the City of Oglesby shall be paid a salary in the amount of \$22.00 per hour and shall receive benefits as provided by for in the Employment Agreement entered into between the City of Oglesby and the International Brotherhood of Electrical Workers Local 51, as amended from time to time.

4. For the period from May 1, 2020 to April 30, 2021, the City Clerk shall be paid a salary in the amount of \$22.44 per hour and receive benefits as provided for in the Employment Agreement entered into between the City of Oglesby and the International Brotherhood of Electrical Workers Local 51, as amended from time to time from May 1, 2020 through April 30, 2021.

5. The wage for the City Clerk set forth in this ordinance shall be paid retroactive to July 1, 2019 and shall continue to April 30, 2020. The 2% per hour salary increase provided for the Oglesby City Clerk effective May 1, 2020 shall continue until April 30, 2021. After April 30, 2021, the Oglesby City Council will reevaluate the salary to be paid to the Oglesby City Clerk.

6. This ordinance shall be in full force and effect from and after its passage, approval and due publication in pamphlet form as provided by law.
