AN ORDINANCE AUTHORIZING THE EXECUTION OF A WATER EASEMENT AGREEMENT

WHEREAS, the City of Oglesby desires to obtain an easement for a water line running through property owned by Roderick L. Knoblauch, Delores A. Knoblauch, Kevin R. Knoblauch, James D, Knoblauch, Douglas E. Knoblauch and Kimberly A. Knoblauch; and WHEREAS, the City of Oglesby and Roderick L. Knoblauch, Delores A. Knoblauch, Kevin R. Knoblauch, James D, Knoblauch, Douglas E. Knoblauch and Kimberly A. Knoblauch have agreed to the execution of an easement agreement in the form and substance as set forth in Exhibit A attached hereto and incorporated by reference as if set out in full herein;

WHEREAS, Section 11-129-1 of the Illinois Municipal Code (65 ILCS 5/11-129-1) authorizes municipalities to build or purchase and to operate a waterworks system or water supply system and by implication authorizes a municipalities to obtain easements for water lines; and

WHEREAS, the Mayor and Commissioners of the City of Oglesby deem it to be in the best interest of the public health and welfare of the residents of the City of Oglesby to obtain an easement for the construction of a water line through the Roderick L. Knoblauch, Delores A. Knoblauch, Kevin R. Knoblauch, James D, Knoblauch, Douglas E. Knoblauch and Kimberly A. Knoblauch property.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated by reference

as if set out in full herein.

- The City of Oglesby is hereby authorized to enter into the Water Easement Agreement in the form and substance as set forth in Exhibit A which is incorporated by reference and restated as if set out in full herein.
- 3. After the adoption of this ordinance, the Mayor of the City of Oglesby and the City Clerk of the City of Oglesby are authorized to sign the easement agreement attached hereto as Exhibit A.
- 4. This ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
