AN ORDINANCE AMENDING ORDINANCE NO. 1081-091619 ENTITLED
AN ORDINANCE AUTHORIZING GOLF CARTS/NEIGHBORHOOD VEHICLES
FOR USE WITHIN THE CORPORATE LIMITS OF THE CITY OF OGLESBY

WHEREAS, the City of Oglesby adopted Ordinance No. 1081-091619 entitled An Ordinance Authorizing Golf Cars/Neighborhood Vehicles for Use Within the Corporate Limits of the City of Oglesby; and

WHEREAS, it has come to the attention of the City of Oglesby that certain provisions in Ordinance No. 1081-091619 should be amended to clarify the types of vehicles permitted to Ordinance No. 1081-091619; and

WHEREAS, Section 11-80-2 (65 ILCS 5/11-80-2) of the Illinois Municipal Code grants to the corporate authorities of each municipality the power to regulate the use of streets or other municipal property.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this ordinance are incorporated by reference as if set out in full herein.

2. Section 10.60.010 GOLF CARTS/NEIGHBORHOOD VEHICLES defined and permitted of Ordinance No. 1081-091619 entitled An Ordinance Authorizing Golf Carts/Neighborhood Vehicles for Use Within the Corporate Limits of the City of Oglesby shall be amended to read as follows:

A "golf cart," as defined herein, means a vehicle specifically designed and intended for the purposes of transporting one or more persons and their golf clubs, supervising the play of golf or maintaining the condition of the grounds on a public or private golf course as defined by Section 1-123.9 of the Illinois Vehicle Code.

A "Neighborhood Vehicle," as defined herein means any road-ready electric or gas powered four wheel vehicle, including all-terrain vehicles, as defined in Section 1-101.8 of the Illinois Vehicle Code, all recreational off-highway vehicles, as defined by Section 1-168.8 of the Illinois Vehicle Code and an off-highway motorcycle as defined by Section 1-153.1 of the Illinois Vehicle Code.

"City Streets" mean any of the streets within the boundaries of the City of Oglesby which have a posted maximum speed limit of 30 mph and is not a State Highway.

The operation of golf carts/neighborhood vehicles shall be permitted on streets under the jurisdiction of the City of Oglesby and/or with its intersection controlled by a traffic light or four-way stop sign upon or across any highway under the jurisdiction of the State of Illinois as set forth in Section 11-1426.1 of the Illinois Vehicle Code (625 ILCS 5/11-1426.1).

3. All of the remaining provisions of Ordinance No. 1081-091619 entitled An Ordinance Authorizing Golf Carts/Neighborhood Vehicles for Use Within the Corporate Limits of the City of Oglesby not otherwise amended or modified by this ordinance shall remain in full force and effect.

4. This ordinance shall be in full force in effect after its passage, approval, and publication in pamphlet form as provided by law.
