#### **ORDINANCE NO. 1219-050123**

## AN ORDINANCE DESIGNATING ELECTED COMMISSIONERS TO SPECIFIED DEPARTMENTS

WHEREAS, pursuant to Section 5/4-5-3 of the Illinois Municipal Code (65 ILCS 5/4-5-3) the Oglesby City Council, at its first regular meeting after an election, shall designate by a majority vote of the Commissioners a Commissioner to be Superintendent of each specified City department; and

WHEREAS, the elected Commissioners of the City of Oglesby desire to make the Commissioner designations for each department as specified herein; and

WHEREAS, the Oglesby City Council deems the designations specified herein to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby.

# NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.
- 2. The elected Commissioners of the City of Oglesby are hereby designated to the following departments designated by statute:
  - A. ANTONIO STEFANELLI Commissioner of Accounts and Finances;
  - B. TERRY M. EUTIS Commissioner of Public Health and Safety;
  - C. GREGORY MCDERMOTT Commissioner of Streets and Public Improvement; and
  - D. RICHARD BALDRIDGE Commissioner of Public Property.

Additionally, the Mayor (by statute) is automatically designated as the Commissioner of Public Affairs.

3. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
