**ORDINANCE NO. 1221-050123**

**AN ORDINANCE REVISING VARIOUS PROVISIONS  
OF THE MUNICIPAL CODE OF THE CITY OF OGLESBY  
RELATING TO COMMISSION, BOARD AND COMMITTEE APPOINTMENTS**

**WHEREAS**, the Mayor and Commissioners of the City of Oglesby desire to make amendments to various provisions the Oglesby City Code relating to the required composition of various Commissions, Boards and Committees of the City established by previous Ordinance; and

**WHEREAS**, Section 4-5-1, et seq., of the Illinois Municipal Code (65 ILCS 5/4-5-1) authorizes the city council in a Commission form of government to determine the composition of various Commissions, Boards and Committees established by the City as may be necessary or proper for the efficient and economical conduct of the business of the City; and

**WHEREAS**, Oglesby City Council desires to make amendments to certain sections of the Oglesby City Code to amend the composition of several of its Commissions, Boards and Committees as set forth herein; and

**WHEREAS**, the Oglesby City Council deems the changes to be made by this Ordinance to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:**

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.
2. The existing Section "2.57.020 – Members." of the Oglesby Municipal Code

is hereby deleted in its entirety and the following is hereby substituted in its place:

2.57.020 – Members.

The plan commission shall consist of eleven (11) members of the general public, who must be residents of the City of Oglesby and who shall be appointed by the mayor, subject to the approval of the city council.

3. The existing Section “2.75.030 – Board of Directors - Established.” of the Oglesby Municipal Code is hereby deleted in its entirety and the following is hereby substituted in its place:

2.75.030 – Board of Directors – Established.

An ambulance service board of directors is hereby created, which board shall consist of seven (7) members, two (2) of which shall be non-voting members of the board, namely: the City’s fire chief and ambulance service director. The five (5) voting members shall consist of residents of the City of Oglesby who shall be appointed by the mayor, subject to the approval of the city council.

4. The existing Section “2.88.010 – Creation – Composition” of the Oglesby Municipal Code relating to the City’s Design and Review Board is hereby deleted in its entirety and the following is hereby substituted in its place:

2.88.010 – Creation – Composition.

There is created a design and review board in the City, whose five members shall consist of three (3) members of the City’s plan commission, plus the City’s building inspector one (1) resident of the City of Oglesby. All members shall be appointed by the mayor, subject to the approval of city council.

5. The membership in the City’s Building Improvement Grant Committee (sometimes referred to as the City’s facade improvement program) is hereby amended to be as follows:

The committee shall consist of seven (7) members, which shall include the City’s Economic Development Director plus six (6) residents of the City of Oglesby who shall be appointed by the mayor, subject to the approval of the City council. The mayor shall also appoint the chairman of said committee, subject to the approval of the City council.

6. All Ordinances or parts of Ordinances or provisions of the Municipal Code or Rules or Regulations of the City of Oglesby which are inconsistent with the dictates of this Ordinance are hereby stricken and repealed.

7. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
