**AN ORDINANCE ESTABLISHING THE SALARY
AND BENEFITS FOR THE OGLESBY CITY CLERK**

WHEREAS, the City of Oglesby desires to establish the wage and benefits to be provided to the newly appointed Oglesby City Clerk; and

WHEREAS, Section 4-6-2 of the Illinois Municipal Code (65 ILCS 5/4-6-2) authorizes the City of Oglesby to set compensation for all officers and employees of the City of Oglesby; and

WHEREAS, the Mayor and City Council of the City of Oglesby deem it to be in the best interests of the public health, safety and welfare of the residents of the City of Oglesby to adopt an ordinance setting the salary and benefits to be paid to the Oglesby City Clerk;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are restated and incorporated by reference as if set out in full herein.

2. For the period commencing May 1, 2023, and continuing until hereafter amended, the City Clerk of the City of Oglesby, LaSalle County, Illinois shall be paid an annual salary of Sixty-seven Thousand, Seven Hundred Four and no/100 Dollars (\$67,704.00) and shall receive benefits as required by any Labor Agreement entered into between the City of Oglesby, LaSalle County, Illinois and the International Brotherhood of Electrical Workers Local 51, as amended from time to time, to City employees. In

addition, should the City Clerk work more than eighty-four (84) hours during any established two-week pay period, the City Clerk shall be paid a bonus of Forty-six and 50/100 Dollars (\$46,50)per hour for each hour worked in excess of said eighty-four (84) hours

3. The salary for the City Clerk specified in paragraph "2." of this Ordinance shall be paid retroactive to May 1, 2023.

4. In addition, the City Clerk shall be credited with three (3) weeks of vacation time, effective May 1, 2023.

5. This Ordinance shall apply so long as Oglesby City Clerk REBECCA CLINARD holds the position of City Clerk in the City of Oglesby. In the event of her retirement, resignation or discharge, the salary and benefits provided in this Ordinance shall terminate and any newly appointed City Clerk shall be paid wages and benefits to be determined by an Ordinance adopted by the City Council of the City of Oglesby at the time of the appointment of a new City Clerk

6. This Ordinance shall be in full force and effect from and after its passage, approval and due publication in pamphlet form as provided by law.

7. The City Clerk is hereby instructed to publish this Ordinance in pamphlet form as required by law.
