AN ORDINANCE REVISING PARAGRAPH "B. f." OF SECTION 5.08.050 OF THE MUNICIPAL CODE OF THE CITY OF OGLESBY RELATING TO RESIDENCY FOR LIQUOR LICENSE APPLICANTS

WHEREAS, the Mayor and Commissioners of the City of Oglesby desire to make an amendment to Chapter 5.08.050 of the Municipal Code of the City of Oglesby; and

WHEREAS, the City has previously established rules, regulations and procedures relating to applications for City liquor licenses; and

WHEREAS, the Oglesby City Council desires to make an amendment to paragraph "B. f." of Chapter 5.08.050 of the Oglesby Municipal Code amending residency information for any liquor license applicant; and

WHEREAS, the Oglesby City Council deems the change to be made by this Ordinance to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.
- 2. The existing paragraph "B. f." of Section 5.08.050 of the Municipal Code of the City of Oglesby is hereby deleted in its entirety and the following is hereby substituted in its place:
 - f. The residence address for any applicant.
- 3. All Ordinances or parts of Ordinances or provisions of the Municipal Code or rules or regulations of the City of Oglesby which are inconsistent with this Ordinance are

hereby stricken and repealed.

4. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
