ORDINANCE NO. 1227-070523

AN ORDINANCE REVISING “TABLE A” IN PARAGRAPH “A.” OF CHAPTER 8.64.070 OF THE MUNICIPAL CODE OF THE CITY OF OGLESBY RELATING TO MAXIMUM SOUND PRESSURE LEVELS FOR CONTINUOUS SOUNDS

WHEREAS, the Mayor and Commissioners of the City of Oglesby have previously enacted Ordinances designating maximum sound pressure levels for continuous sounds in the City of Oglesby, LaSalle County, Illinois, which maximum sound pressure levels are set forth in Chapter 8.64.070 of the Municipal Code of the City of Oglesby; and

WHEREAS, pursuant to the Petition of several business owners, the Mayor and Commissioners of the City of Oglesby desire to amend the existing time limits set forth in Table A in Chapter 8.64.070 of the Municipal Code of the City of Oglesby; and

WHEREAS, the Mayor and Commissioners of the City of Oglesby deem the change to be made by this Ordinance to be in the best interest of public health, safety and welfare of the residents of the City of Oglesby.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

1. The recitals contained in the preamble to this Ordinance are incorporated by reference as if set out in full herein.

2. The existing “Table A” set forth in paragraph “A.” of Chapter 8.64.070 of the Municipal Code of the City of Oglesby is hereby deleted in its entirety and the following two (2) tables are hereby substituted in its place:

3. All Ordinances or parts of Ordinances or provisions of the Municipal Code or rules or regulations of the City of Oglesby which are inconsistent with this Ordinance are hereby stricken and repealed.

4. This Ordinance will be in full force and effect after its passage, approval, and publication in pamphlet form as provided by law.
