A MOTION WAS MADE BY Stefanelli, **SECONDED BY** McDermott to approve the contract with Connecting Point for backup of the server. The new contract saves the city \$948 a year. **AYES:** Baldrige, Eutis, McDermott, Stefanelli, Curran. **NAYS:** None. **MOTION CARRIED.**

- Announced that Aiden Anderson was the recipient of the IMEA \$1,000 scholarship.
