ORDINANCE NO. 1262-071524

AN ORDINANCE AMENDING SECTION 2.03.090, REGULAR MEETINGS, OF CHAPTER 2.03, COUNCIL, OF TITLE 2, ADMINISTRATION AND PERSONNEL, OF THE CITY CODE OF THE CITY OF OGLESBY, LASALLE COUNTY, ILLINOIS

WHEREAS, the City Council of the City of Oglesby, LaSalle County, Illinois, have previously enacted Section 2.30.090, Regular Meetings, of the City Code, which states that regular meetings of the City Council shall be held on the first and third Monday of each an every month, at the hour of Seven p.m.; and

WHEREAS, the City Council of the City of Oglesby desire to change the time of the regular meetings from Seven p.m. to Six p.m.; and

WHEREAS, Section 5/3.1-40-25 of the Illinois Municipal Code (65 ILCS 5/3.1-40-25) grants the City Council the authority to establish the time and place of regular City Council Meetings.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Oglesby, LaSalle County, Illinois:

SECTION 1: That the current City Code Section 2.03.090, Regular Meetings, of Chapter 2.03, Council, of Title 2, Administration and Personnel, of the City Code of the City of Oglesby be deleted in its entirety and replaced with the following:

The regular meetings of the Council shall be held in the Council Rooms in the City Hall on the first and third Mondays of each and every month, at the hour of Six p.m., except when such day may happen to be a legal

holiday, in which case the meeting shall be held on the day next following at the same hour.

SECTION 2: That this Ordinance shall be in full force and effect after its passage, approval, and publication, as provided by law.
